The Down East Sale committee is seeking consignors who are willing to offer top quality cattle from their herds to enhance the future of this event.

GUIDELINES FOR CONSIGNMENT
FORMS DUE TO NCAA BY **AUGUST 25, 2018**

Requirements for Registered Black Angus Females:

- All females must be sound and less than 8 years old on November 3, 2018 (Calved on or after November 3, 2010).
- All cattle born on or before November 3, 2016 **MUST** be safe in calf as determined by pregnancy examination OR nursing a calf. (No blood tests for pregnancy will be accepted.)
- Body condition score of **6** or better. If you're not sure how your entries score, contact a member of the sale committee or your county livestock agent.

Requirements for Angus Influenced Females:

- All females must be sound and less than 8 years old on November 3, 2018 (Calved on or after November 3, 2010).
- All cattle born on or before November 3, 2016 **MUST** be safe in calf as determined by pregnancy examination OR nursing a calf. (No blood tests for pregnancy will be accepted.)
- Body condition score of 6 or better.
- At least one parent **MUST** be a **REGISTERED Black Angus.**
- Angus influenced cattle must also meet CAB Program Live Animal Specifications:
 1. Black/ white face cows (Baldies) are acceptable.
 2. Cattle must have typical beef type conformation (no visible dairy influence).
 3. Cattle must be absent of long, floppy ears and humps (no visible Brahman influence).

NO BULLS in the sale.

HEALTH PAPERS: North Carolina Angus Association requires you to have Health Papers for each lot you consign. These papers must show a negative test for **Tuberculosis (TB) and Brucellosis taken within 30 days prior to sale date** unless coming from a certified and accredited herd and then please have a copy of the latest accreditation and certification. All cattle who will be sold as pregnant should have the pregnancy exam by a qualified veterinarian with approximate months pregnant written on the health paper. Health papers must accompany cattle to the sale site.

CATTLE MUST BE IN THE SALE FACILITY BY 3 P.M. on Friday, November 2, 2018.

Please have with you at that time:

- SIGNED, original **registration papers** with up to date breeding information: INCLUDE if she is bred (AI breeding date and bull registration number; **ALL** pasture exposure dates, if herd bull bred and bull registration number)
- Name, date of birth, sire and dam registration number if you have an unregistered calf; be sure to have A-I certificate on file with AAA.
- If your papers are electronically store, please have a "paper copy" of the registration, for the secretary to transfer to insure timely transfer of all papers.

- If the cow is sold A.I. bred or sold SAFE – Current AAA Sale Terms and Conditions state: *A.I. Service certificates will be the responsibility of the buyer unless otherwise specified by the seller.* However as a service to the buyer of your animal you should consider adding an A.I. certificate to the buyer's inventory with American Angus Association after the calf is born and verified from the A.I. sire.

SALE FEES: If you pull your lot out of the sale after the catalog is printed, you forfeit your \$25 consignment fee. If your animal goes through the ring and you do not sell her, you share in the sales expenses.

Sale Percentage for sponsored sales by North Carolina Angus Association will be 4% for ALL sales, plus the other normal expenses incurred (i.e.: facility, auctioneer, advertising, catalogs, etc.).

WORK COMMITTEE: Consigners will be asked to serve on work detail committees. Please be prepared to assist as needed.

SUBSTITUTE LOTS: In the event an animal becomes ineligible due to injury, illness or reproductive problems, it is strongly encouraged that the consigner replace it with a comparable substitute that will be subject to approval upon delivery to the sale by the sale committee.

PHOTOS: Consigners are encouraged to provide photos of their animals to be used in the catalog and for advertising. ***Only quality pictures will be used as long as the committee agrees that they will add value to the lot and the sale.***

ALL CATTLE ARE SUBJECT TO APPROVAL BY THE SALE COMMITTEE: Roy Outlaw, chairman: 919-222-9788 and John Smith 252-568-4271. Screening will be done between August 25 & September 15. The committee will also review cattle at sale site and reject cattle that are not acceptable on that date.

NCAA Membership: Consignors must be members of the NC Angus Association.

Resolution Regarding AAA Recognized Defects in Registered Angus Cattle Consigned to North Carolina Angus Association Sponsored Sale

NCAA Board of Director's resolution regarding genetic defects in registered Angus cattle consigned to all North Carolina Angus Association sponsored sales. *January 5, 2014*

"As long as a consignment has a valid registration paper and the carrier status is noted in the sale catalog, we will accept those animals on our Association sponsored sales."

The Down East Sale Committee highly recommends that you only consign cattle that are designated as being **FREE** of any genetic defects or conditions.
